

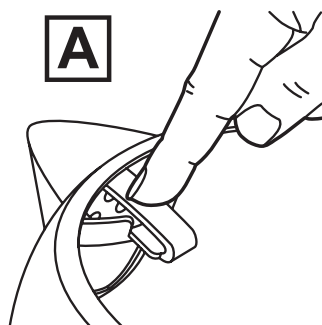
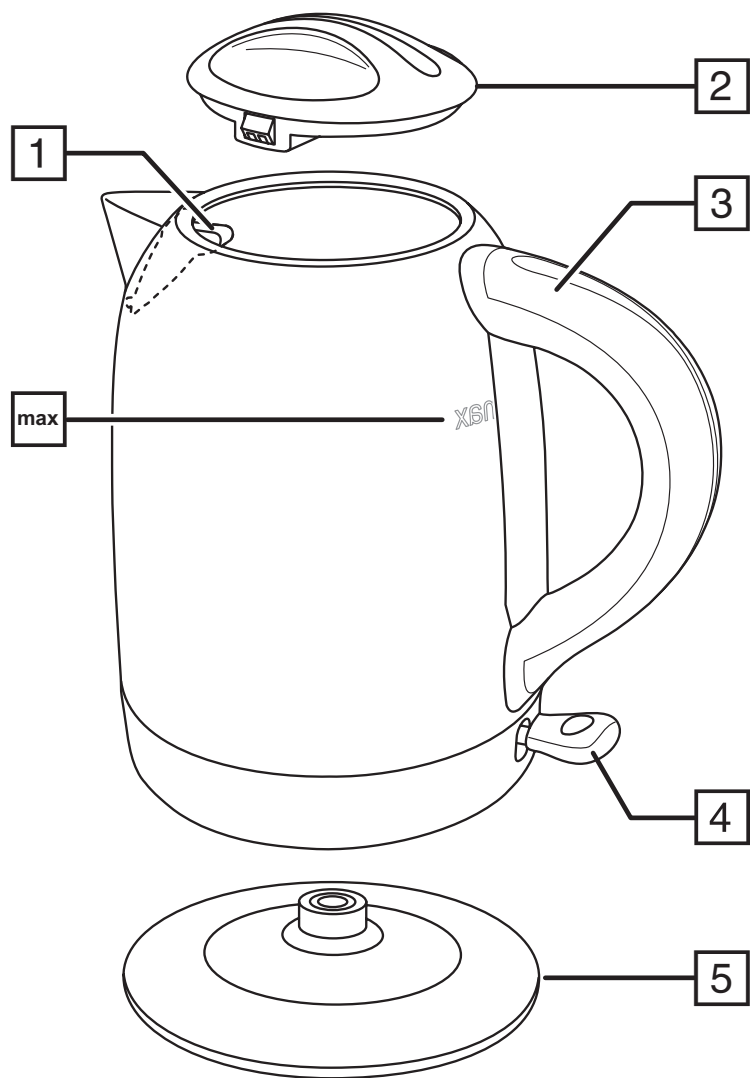

IMPORTANT SAFEGUARDS

Follow basic safety precautions, including:

-  The appliance must not be immersed.
 -  Parts of the appliance will get hot during use.
1. This appliance is not intended for use by persons (including children) with reduced physical, sensory or mental capabilities, or lack of experience or knowledge, unless they have been given supervision or instruction concerning use of the appliance by a person responsible for their safety.
 2. Children shall not play with the appliance.

BEFORE FIRST USE

Fill to **max**, boil, discard the water, then rinse. Do this twice to remove any manufacturing dust, etc.

FILLING

1. Remove the lid.
2. Fill with at least 1 cup of water, but not above **max**.
3. Refit the lid.

USING YOUR KETTLE

1. Put the stand on a stable, level surface. Wind excess cable beneath the stand.
2. Plug the stand into the wall socket.
3. Put the kettle on the stand.
4. Move the switch to **I**. The kettle will start to heat.
5. When it boils, the kettle will switch off.
6. To switch off manually, move the switch to **O**, or simply lift the kettle off the stand

GENERAL

When you lift the kettle, you may see moisture on the stand. Don't worry, it's the steam used to switch off the kettle which is allowed to escape via vents under the kettle.

BOIL DRY PROTECTION

If your kettle boils dry, a safety cut-out device will automatically switch it off. If this happens, unplug your kettle and allow it to cool down until the cut-out resets itself. Allowing your kettle to boil dry will shorten the life of the element.

CARE AND MAINTENANCE

1. Unplug the stand, and let the kettle cool before cleaning.
2. Wipe all surfaces with a clean damp cloth.
3. Keep the connectors dry.
4. Open the lid.
5. Push the hook on top of the filter down then lift the filter out of the kettle (fig A).
6. Rinse the filter under a running tap while brushing with a soft brush.
7. Lower the filter into the kettle, and engage the bottom hook in the bottom of the spout.
8. Press the top of the filter towards the kettle, to lock the hook in place.
9. Close the lid.

Descale regularly, at least monthly

Descale the appliance at least monthly with a proprietary descaler.
Follow the instructions on the package of descaler.

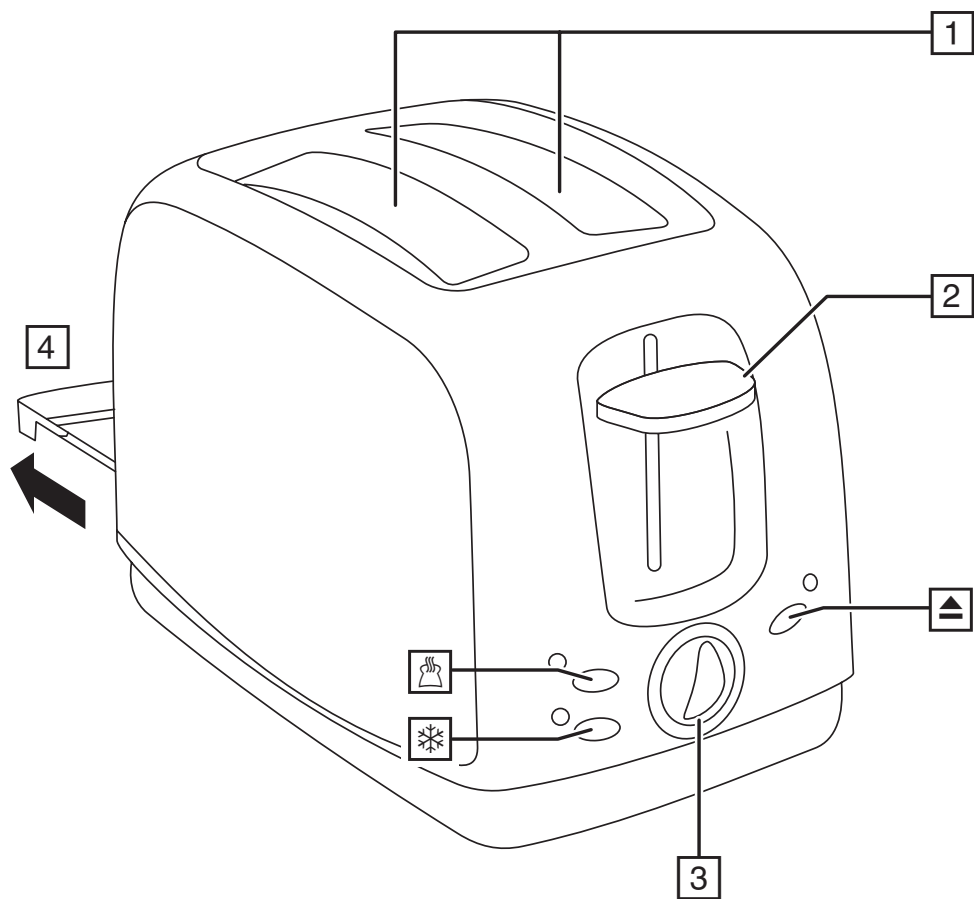

1. This appliance is not intended for use by persons (including children) with reduced physical, sensory or mental capabilities, or lack of experience or knowledge, unless they have been given supervision or instruction concerning use of the appliance by a person responsible for their safety.
2. Children shall not play with the appliance.
3. Cleaning and user maintenance shall not be made by children.
4. Keep the appliance and power cord out of reach of children or persons with reduced physical, sensory and mental capabilities.
5. If the supply cord is damaged, it must be replaced by the manufacturer, its service agent, or someone similarly qualified, to avoid hazard.
6. Do not connect the appliance via a timer or remote control system.
7. Bread may burn. Do not use the appliance near or below combustible materials e.g. curtains, overhead cupboards.
8. Do not leave the toaster unattended when in use.
9. Do not operate the appliance if it is damaged or has malfunctioned.
10. Clean the crumb tray regularly. If not cleaned it may create a fire hazard.
11. Do not toast or reheat buttered, torn or misshapen bread.
12. Route the power cord so it does not overhang, and cannot be caught accidentally.
13. If bread gets jammed, unplug the toaster, let it cool, and carefully remove the bread.
14. Do not use this appliance for other than its intended purpose.
15. Do not cover or place anything on top of the appliance.
16. Do not use the toaster without the crumb tray fitted.
17. Always turn off and unplug from the wall power outlet when not in use and before cleaning the appliance.
18. Do not insert fingers into the toasting slots to lift or carry the toaster.
19. For added safety, electrical appliances should be connected to a power outlet that is protected by a residual current device (RCD), often referred to as a 'Safety Switch. Your switchboard may already incorporate an RCD. If unsure, call an electrician for verification and fitting if necessary.

BEFORE USING FOR THE FIRST TIME

1. Set the browning level to maximum.
2. Operate the appliance empty, to cure the new elements.
3. This may smell a bit, but it's nothing to worry about. Ensure the room is well ventilated.

TOASTING BREAD

1. Sit the toaster upright on a firm, level, heat-resistant surface.
2. Put the plug into the power socket.
3. Turn the browning control to the required setting (1 = light, 7 = dark).
4. Put bread into the toasting slots (maximum thickness 26mm).
5. Press the lever down fully. It won't lock down unless the toaster is connected to the electricity supply.
6. The ▲ light will come on and the elements will heat up.
7. When it's done, the toast will pop up.
8. To stop toasting, press ▲.

FROZEN BREAD

1. Leave the browning level at your favoured setting, insert the frozen bread, lower the lever, then press ❄.
2. The ❄ light will come on, and the toasting time will be altered automatically to give the same degree of browning you get with unfrozen bread.

REHEATING TOAST

1. Leave the browning control at your favoured setting, insert the bread, lower the lever, then press 🔥.
2. The 🔥 light will come on, and the toast will be given a short burst of heat.
3. Don't reheat buttered, torn, or misshapen bread.

HINTS AND TIPS

- Old (yesterday's) bread has less moisture, so makes crisper toast.
- Old bread, thin slices, and sweet bread products (tea cakes, fruit loaf, etc.) brown faster – use a lower setting.

CARE AND MAINTENANCE

- Unplug the toaster and let it cool down.
- Wipe outer surfaces with a damp cloth.
